PERMIT

TO DIVERT OR WITHDRAW FOR BENEFICIAL USE THE PUBLIC WATERS

This permit is issued to the landowner named below in accordance with the provisions of the Mississippi Water Laws, Mississippi Code, et seq.(1972, as amended), and the regulations and standards as promulgated thereunder. Whether or not specifically named in the applications for this permit, anyone using water from the diversion/withdrawal point described below shall do so in compliance with the provisions of this permit. Neither this permit, nor any authority conferred hereby, may be sold, conveyed, encumbered, assigned or transferred, for any period of time or under any conditions whatsoever. This permit may not be modified, transferred, or revoked without the approval of the Permit Board. Any attempts to modify, transfer or revoke this permit, or to take any other action on this permit, shall be invalid and unenforceable and may result in immediate revocation or suspension of this permit. The holder of this permit shall at all times be responsible for compliance with the terms and conditions of this permit. No agreement between the permit holder and any other party shall affect the obligations of the permit holder. Water use under this permit is allowed only when the streamflow or lake level elevation (whichever is applicable) is above the established minimum, pursuant to Mississippi Code Section 51-3-7. Authorization is hereby granted to divert water for the beneficial use designated herein, and for no other purpose, subject to the following terms, conditions, and limitations:

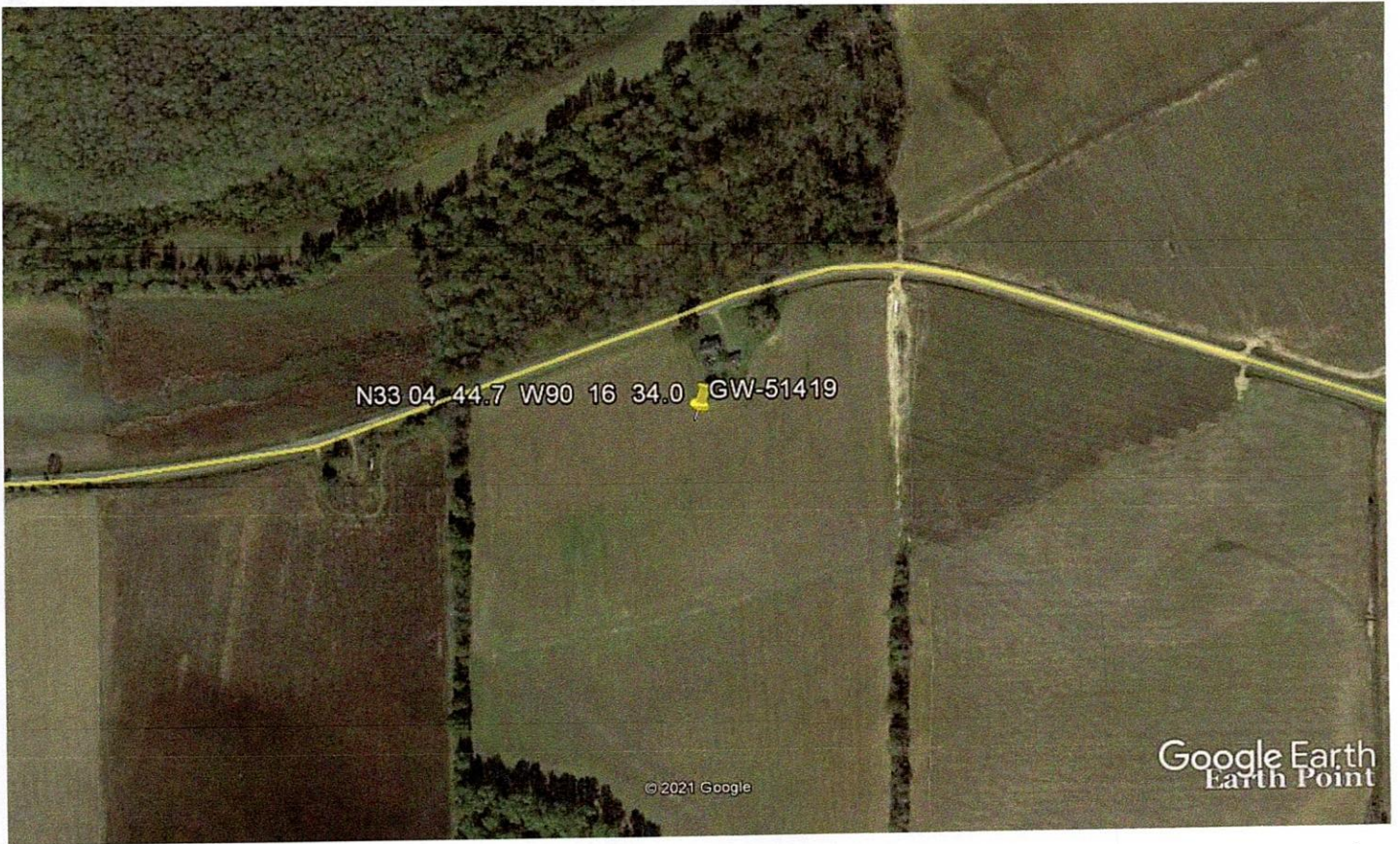

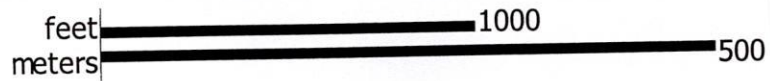
