DESCRIBE HOW THE WELL OR HOLE WAS PLUGGED (AMOUNT OF CASING AND/OR SCREEN THAT WAS REMOVED OR LEFT IN HOLE, MATERIAL AND AMOUNT USED IN PLUGGING, METHOD OF PLACING MATERIAL, ETC.)

The abandonment procedure was discussed with James Crawford and Tommie Whitten, Mississippi Department of Environmental Quality, Office of Land and Water Resources. The grout was mixed in approximate proportions of 94 lbs Portland cement, 5 lbs granulated bentonite, and 8 gallons of water. Installed 100 ft of tremie pipe in well casing, pumped grout through tremie pipe until grout return from well casing, removed tremie pipe, cut well casing off approximately one foot below grade, grouted around outside of well casing to depth of approximately one foot below grade, topped off grout the next day. Well grouted in place.
