DESCRIBE HOW THE WELL OR HOLE WAS PLUGGED (AMOUNT OF CASING AND/OR SCREEN THAT WAS REMOVED OR LEFT IN HOLE, MATERIAL AND AMOUNT USED IN PLUGGING, METHOD OF PLACING MATERIAL, ETC.)

Pulled the pump out of the well, sanded up the well screen to 190' below the top of casing. Run in 190 ft of tremie pipe and pumped 300 gallons of 13.8 ppg cement/bentonite grout slurry from bottom of the well to the top. Let settle over night, tagged grout at 24' below top of casing. Pumped 35 gallons oc cement/bentonite grout slurry. Let settle, and topped off with portland cement and crowned above casing.
