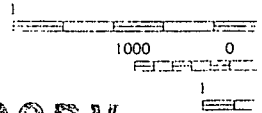

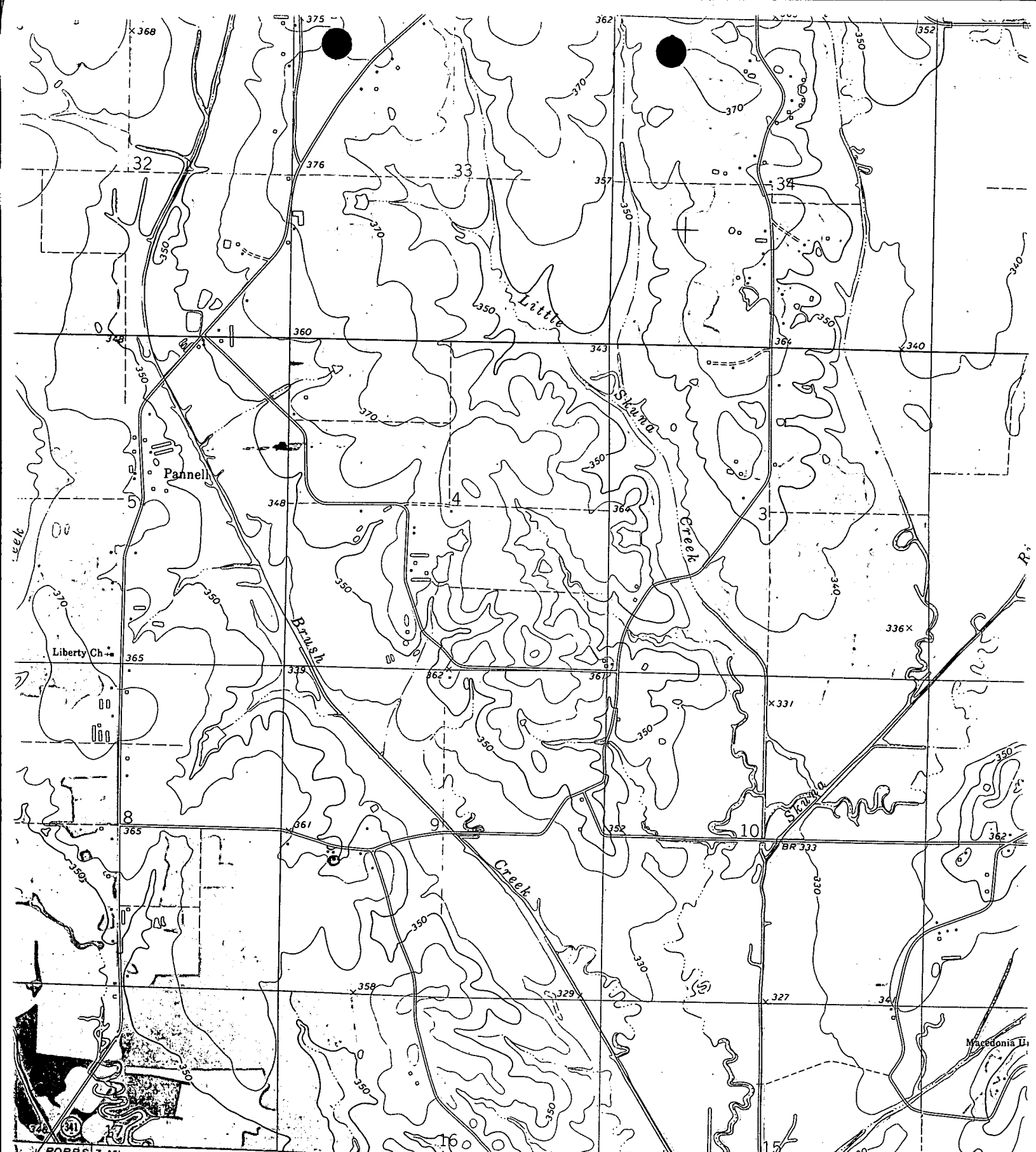
Projection and 10,000-foot grid ticks: Mississippi coordinate system, east zone (transverse Mercator)

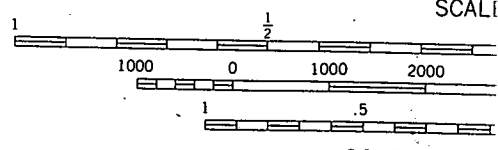
