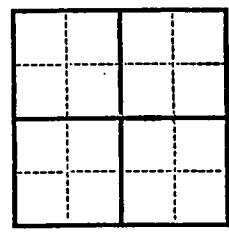

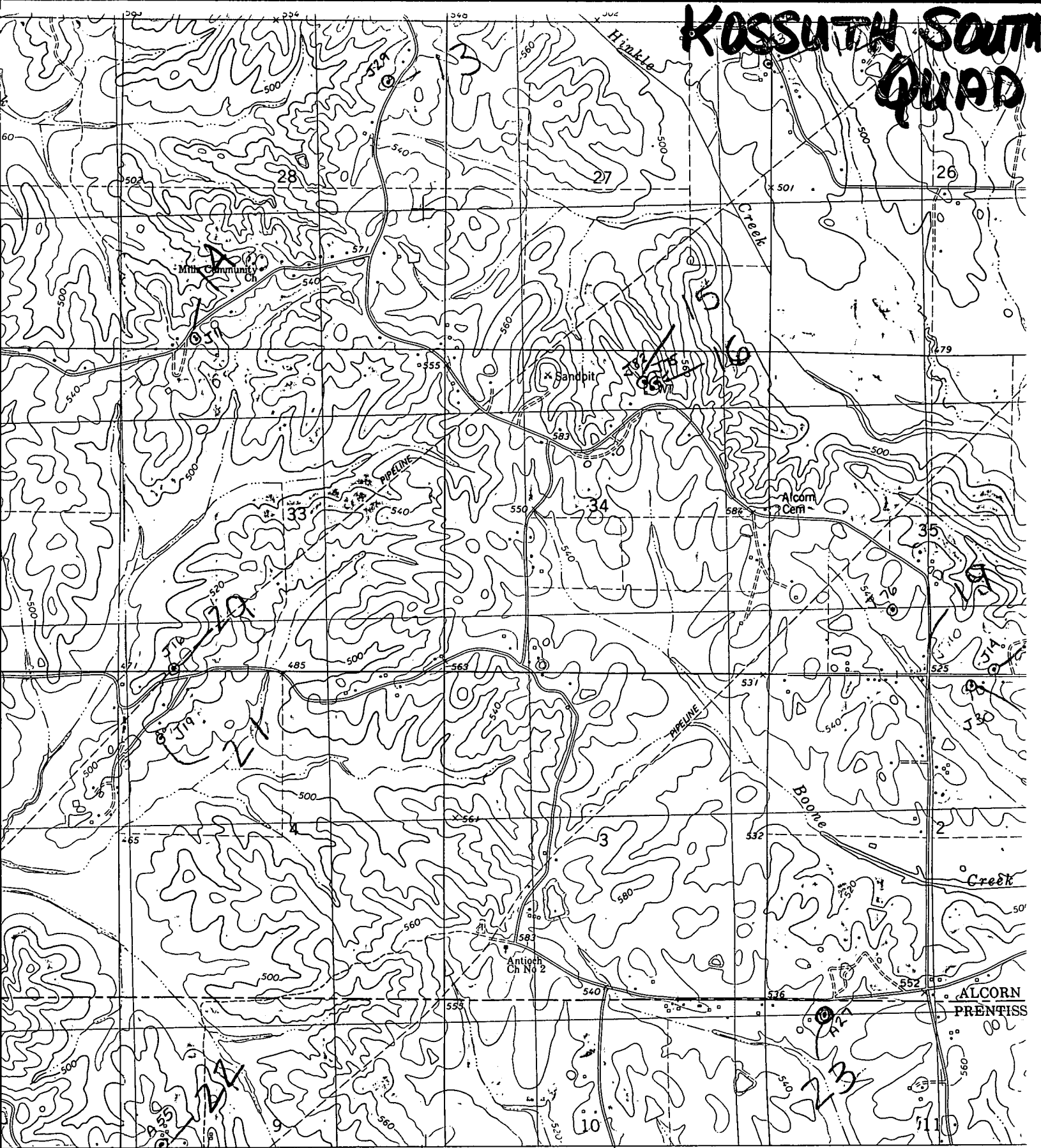
CITY LINE ROAD

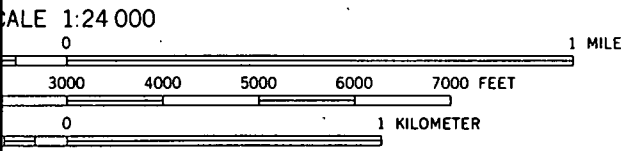
